BUDGET & APPROPRIATION ORDINANCE

LAKE VILLA TOWNSHIP

ORDINANCE No. 14- 1

An ordinance appropriating for all town purposes for Lake Villa Township, Lake County, Illinois, for the fiscal year beginning April 1, 2014 and ending March 31, 2015.

BE IT ORDAINED by the Board of Trustees of Lake Villa Township, Lake County, Illinois.

SECTION 1: That the amounts hereinafter set forth, or so much thereof as may be authorized by law, and as may be needed or deemed necessary to defray all expenses and liabilities of Lake Villa Township, be and the same are hereby appropriated for the town purposes of Lake Villa Township, Lake County, Illinois as hereinafter specified for the fiscal year beginning April 1, 2014 and ending March 31, 2015.

SECTION 2: That the following budget containing an estimate of revenues and expenditures is hereby adopted for the following funds, General Town, General Assistance, Park, Illinois Municipal Retirement and Social Security.



For the fiscal year beginning April 1, 2014 and ending March 31, 2015.


SECTION 6: That Section 3 shall be and is a summary of the annual Appropriation Ordinance of this Township, passed by the Board of Trustees as required by law and shall be in full force and effect from and after this date.

SECTION 7: That a certified copy of the Budget & Appropriation Ordinance shall be filed with the County Clerk within 30 days after adoption.


