AN ORDINANCE LEVYING TAXES FOR ALL ROAD PURPOSES FOR THE LAKE VILLA TOWNSHIP ROAD DISTRICT, LAKE COUNTY, ILLINOIS FOR THE TAX YEAR 2018, COLLECTABLE IN 2019,

BE IT ORDAINED by the Board of Trustees of Lake Villa Township, Lake County, Illinois, as follows:

SECTION 1: That the sum of \$2,765,000.00 two million seven hundred and sixty five thousand five hundred and 00/100 are hereby levied upon all property subject to taxation within the township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the township highway department as required by statute or voted by the people in accordance with the law, for such purposes as: General Road, Permanent Road, Equipment & Building, General Insurance, IMRF & FICA for the year 2018.

SECTION 2: The amount levied for each object and purpose shall be

SECTION 6: That this ordinance shall be in full force and effect after its adoption, as provided by law.
