ORDINANCE No. 2023-6

AN ORDINANCE LEVYING TAXES FOR ALL ROAD PURPOSES FOR THE LAKE VILLA TOWNSHIP ROAD DISTRICT, LAKE COUNTY, ILLINOIS FOR THE TAX YEAR 2023, COLLECTABLE IN 2024,

BE IT ORDAINED by the Board of Trustees of Lake Villa Township, Lake County, Illinois, as follows:

SECTION 1: That the sum of \$3,165,751 three million, one hundred and sixty five thousand, seven hundred and fifty one dollars and 00/100 are hereby levied upon all property subject to taxation within the township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the township highway department as required by statute or voted by the people in

accordance with the law, for such purposes as: General Road, Permanent Road, Equipment & Building, General Insurance, IMRF & FICA for the year 2023.
