AN ORDINANCE LEVYING TAXES FOR ALL ROAD PURPOSES FOR THE LAKE VILLA TOWNSHIP ROAD DISTRICT, LAKE COUNTY, ILLINOIS FOR THE TAX YEAR 2024, COLLECTABLE IN 2025,
