LAKE VILLA TOWNSHIP

TAX LEVY ORDINANCE

AN ORDINANCE LEVYING TAXES FOR ALL TOWN PURPOSES FOR THE LAKE VILLA TOWNSHIP, LAKE COUNTY, ILLINOIS FOR THE TAX YEAR 2020, COLLECTABLE IN 2021.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF LAKE VILLA TOWNSHIP, LAKE COUNTY ILLINOIS, AS FOLLOWS:

SECTION 1: That the sum of \$1,659,500.00 one million six hundred and fifty nine thousand five hundred and 00/100 are hereby levied upon all property subject to taxation within the township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the township as required by statute or voted by the people in accordance with the law, for such purposes as:






